EDUCATE - Deliver the Smart Cities Readiness Program, powered by Activator.


CONVENE - Bring our community together to engage in meaningful dialogue to advance best practice.


ADVOCATE - Help shape a policy environment that accelerates smart cities action and investment.

EDUCATE

In 2019 we helped raise awareness and build capacity for smart cities action and investment by:

- Delivering 52 presentations to audiences in all Australian States and Territories, and New Zealand's major cities (Auckland, Christchurch, Hamilton and Wellington)
- Launching our podcast The Smart Cities Chronicles with more than 50 episodes and 10,000+ listens
- Hosting 18 webinars and on-line discovery sessions for local government and the private sector
- Facilitating 10 in-person workshops
- Hosting five Smart Cities Coffee Club peer exchange sessions
- Hosting the inaugural Smart Cities Investment Forum
- Hosting the inaugural National Digital Twin Symposium
- · Facilitating Australia's first 5G Readiness Workshop.

Smart Cities Week Australia is the nations premier gathering of smart cities leaders. Here are the highlights:

- Over 350 delegates participated from 15 countries
- Almost 100 speakers and guests joined us to deliver a program with over 20 plenary and breakout sessions
- 24 best practice case studies were presented across the themes of strategy, transformation, deployment and data
- Three project accelerator sessions in partnership with the City of Canterbury Bankstown covering smart places and spaces, civic data trusts and social wellbeing for smart cities
- A series of data dialogues looking at data privacy, ethics and governance, along with the technical aspects of connectivity, sensing, storage and analytics
- The first in-person meeting of the Local Government Smart Cities Network which gathered more than 30 cities and towns across Australia and New Zealand
- The second year of the Australian Smart Cities Awards program, which yielded over 60 submissions for 13 award categories
- Australia's first 5G Readiness Workshop
- · Launch of the Civic Innovation Maturity Model
- Launch of Mobility Now, a new blueprint for smart and sustainable mobility in Australia and New Zealand
- Australia's first public training session on the Smart Cities Activator.

CONVENE





2019 was a busy year for smart cities policy, with Australia's national general election conducted in May, and multiple state-based policy initiatives seeking to advance smart cities action.

Here is a snapshot of our advocacy work:

- In the lead up to and following the Australian general election, our Policy and Leadership Task Force, along with the Mobility Task Force, spent months preparing our 2019 policy priorities
- In October we tabled a seven page letter with the Hon Allan Tudge MP, Minister for Population, Cities and Urban Infrastructure, outlining a proposed framework for smart cities policy in Australia for the coming years, and articulated the opportunity for smart cities which lies at the intersection with City Deals.
- Maintained active involvement in helping shape smart cities outcomes for the South East Queensland and Western Sydney City Deals by participating in industry advisory committee's and meeting directly with the City Deal teams at local, state and federal levels
- Submission to the NSW Government Draft Smart Infrastructure Policy
- Participation in the National Cities Reference Group meeting, hosted by the Australian Minister for Population, Cities and Urban Infrastructure.

ADVOCATE





IN ADDITION



The Local Government Smart Cities Network (LGSCN) is the most active network of local government representatives across the region. With more than 70 cities and towns now members, this group of policy makers and practitioners is actively sharing knowledge, building capacity and networking.

In 2019 the LGSCN provided cities and towns with a dedicated local government-only forum to participate in:

- Monthly international peer exchanges with cities from North America, Europe and Asia
- Bi-monthly technical deep dives on technology and data issues common to the network members
- Bi-monthly challenge exchanges addressing key barriers and leadership issues such as procurement, strategy and engagement
- An in-person gathering to confirm priority issues for 2020 and network faceto-face
- An online discussion forum
- A digital library of presentations, guidelines and other resources
- Access to the Smart Cities Activator, including Activator Exchange, a realtime library of local government smart cities projects around the world.

AND ACTIVATOR



In May 2019 we launched the Smart Cities Activator, a real time online collaborative platform for enhancing liveability, workability and sustainability outcomes in cities and towns through best practice scoping, designing and financing tools.

In addition, Activator includes a global project exchange (called Activator Exchange) of smart cities projects generated by cities, allowing cities to connect with their peers to share, ask questions and potentially partner.

As part of our Smart Cities Readiness Program, the City of Darwin was the first local authority in the region to receive access to Activator, with initial training now complete and smart cities projects being scoped.

In January 2020 we commence onboarding the South West Group into Activator, which is a regional organisation of councils in Western Australia including City of Cockburn, Town of East Fremantle, City of Fremantle, City of Kwinana, City of Melville and City of Rockingham.
