Smart Cities Council Readiness Program

- Our goal to invite cities to provide information about their needs – from which the Council will work with these cities to accelerate their projects.
- By accelerating project implementation the city, its residents, financiers and solution providers all win.
- Each calendar quarter 1-2 cities will be chosen to lead a Readiness Cohort focusing on accelerating a project. Within each cohort, there will be as many as 50 additional cities seeking similar information.
- All cities will gain access to the Smart Cities
 Activator planning platform and be able to use
 the Readiness Cohort Leader's planning
 template for their own projects.






